MOTION: The Board of Education of the Manhasset Union Free School District hereby adopts the proposed budget of expenditures in the amount of \$100,659,820 for the 2020-2021 school year, and is authorized to levy the necessary tax thereof after first deducting the monies available from State Aid and other sources as provided by law, subject to voter approval. The adoption of this budget would require a tax levy increase of 1.9% which is within the statutory tax levy increase limit of 2.9% for this school fiscal year and, therefore, would not exceed the state tax cap and must be approved by a majority of the qualified voters present and voting.

Whereas bids were opened on 5/15/20 pertaining to the 2019-2020 Capital Improvement Program Phase 2, for both Munsey Park ES and Manhasset MS/HS for contracts 1-4 as follows:

Contract #1 - General Construction

It is hereby recommended that the bid be awarded to Stalco Construction with a low combined bid of \$1,637,704.00, for both locations in conformance with all bids specifications

Contract #2 - Plumbing Reconstruction

It is hereby recommended that the bid be awarded to Seaford Avenue Plumbing with a low combined bid of \$55,972.00, for both locations in conformance with all bids specifications.

Contract #3 - HVAC Reconstruction

It is hereby recommended that the bid be awarded to Ultimate Power with a low combined bid of \$443,000.00, for both locations in conformance with all bids specifications.

Contract #4 - Electrical Reconstruction

It is hereby recommended that the bid be awarded to Eldor Contracting Corporation with a low combined bid of \$284,885.00, for both locations in conformance with all bids specifications.

BE IT HEREBY RESOLVED, that the Board of Education of the Manhasset Union Free School District award contracts 1-4 to the lowest responsible bidders in conformance with all specifications, as outlined above. Total of all four contracts to be awarded amounts to \$2,421,531.00.for Phase 2 of the 2019-2020 Capital Improvement Program.
