The Board of Education of the Manhasset Union Free School District approves the Warrant and Wire Report for the period ended November 2020.

4. Approval of Amendment of Inter-Municipal Agreement with Nassau

County (Enclosures)

WHEREAS, the Manhasset Union Free School District entered into an Inter-Municipal agreement with Nassau County, Contract Number CFCE15000029 (the "Original Agreement") in relation to a legislative grant from the County of Nassau ("County") under the County's Community Revitalization Program in the amount of \$70,000, for the construction/installation of a walkway to the Munsey Park Elementary School from a nearby parking facility (the "Project"); and

WHEREAS, the District was unable to complete the Project within the term of the Original Agreement and the District and the County wish to extend the time so the Project may be completed, by executing an Amendment to the Original Agreement; and

WHEREAS, the Board of Education of the Manhasset Union Free School District is the lead agency under the State Environmental Quality Review Process for the purpose of required determinations respecting the proposed Project, which may include the following projects:

- o Installation of Concrete Pavers
- o Installation of Paver Base
- o Soil Excavation & Grade Changes
- o Handrail Installation
- o Retaining Walls
- o Bushes/Shrubs
- o Drainage Work

WHEREAS, in 1995, amendments were made to the SEQRA Regulation (Part 617) to classify projects, which will be excluded from the requirements for the preparation of an Environmental Impact Statement (Type II Actions); and the projects mentioned above are now classified as Type II Actions as determined by 6 NYCRR §617.5; and

WHEREAS, these projects fall under the following categories:

- A. Maintenance or repair involving no substantial changes in an existing structure of facility;
- B. Replacement, Rehabilitation or Reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building or fire codes, unless such action meets or exceeds any of the thresholds in Section 617.4 of this Part; now, therefore, be it

RESOLVED, that the Board of Education of the Manhasset Union Free School District, as the lead agency for the SEQRA determination, hereby determines that all the above referenced projects fall under Categories "A" or "B" above and, thus, that the procedure for Type II Actions, with regard to the SEQRA Process for the Project noted above is "No Additional Required Action under 6NYCRR§617.5(a)"; and be it further

RESOLVED that the Board of Education of the Manhasset Union Free School District hereby approves the Amendment to the Original Agreement in relation to a legislative grant from the County in the amount of \$70,000 to be used towards the Project; and be it further

RESOLVED that the Board authorizes the Superintendent to execute said Amendment on behalf of the Board.

5. Reaffirmation of Approval of Agreement with Educational Data Services, Inc. and Appointment of Cooperative Bidding (Enclosures)
