I. Proposed Resolution Regarding Commissioner's Regulation Part 123

WHEREAS, on April 18, 2023, the New York State Board of Regents adopted Part 123 of the Regulations of the Commissioner of Education, (8 NYCRR Part 123) regarding the use of indigenous team names, logos and/or school mascots by public schools; and

WHEREAS, pursuant to Part 123, boards of education must commit, via adoption of a resolution by no later than the end of the 2022-23 school year, to eliminate the use of all indigenous names, logos, and mascots within a reasonable time which shall be no later than the end of the 2024-25 school year; and

WHEREAS, the New York State Education Department has advised that district logos or imagery that incorporate symbols associated with indigenous peoples are also prohibited under Part 123; and

WHEREAS, pursuant to Part 123, the District's use of the name "Indians" and any symbols or logos associated with indigenous peoples must be eliminated within the timeframe set forth in Part 123;

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby commits to eliminate the use of the name "Indians" and associated imagery, in accordance with the Commissioner's Regulation Part 123; and

BE IT FURTHER RESOLVED that the Board of Education hereby directs the Superintendent of Schools to create a plan, in accordance with the Commissioner's Regulation Part 123; and

BE IT FURTHER RESOLVED that legacy or memorial items are considered historical artifacts and will not be removed or changed; and

BE IT FURTHER RESOLVED that all school officers and employees of the District are prohibited from utilizing or promoting any indigenous name or associated imagery, whether on District property or at District functions to be held off District property, in accordance

with the Commissioner's Regulation Part 123; and

BE IT FURTHER RESOLVED that the Board of Education hereby directs the Superintendent to make every effort to seek reimbursement from the State of New York for the costs associated with the District's compliance with the requirements of 8 NYCRR Part 123.

12. TAX ANTICIPATION NOTE RESOLUTION

TAX ANTICIPATION NOTE RESOLUTION OF MANHASSET UNION FREE SCHOOL DISTRICT, NEW YORK, ADOPTED JUNE 21, 2023, AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$18,500,000 TAX ANTICIPATION NOTES IN ANTICIPATION OF THE RECEIPT OF TAXES LEVIED OR TO BE LEVIED FOR THE FISCAL YEAR ENDING JUNE 30, 2024

RESOLVED BY THE BOARD OF EDUCATION OF MANHASSET UNION FREE SCHOOL DISTRICT, IN THE COUNTY OF NASSAU, NEW YORK, AS FOLLOWS:

Section 1. Tax Anticipation Notes (herein called "Notes") of Manhasset Union Free School District, in the County of Nassau, New York (herein called "District"), in the principal amount of not to exceed \$18,500,000, and any notes in renewal thereof, are hereby authorized to be issued pursuant to the provisions of Sections 24.00 and 39.00 of the Local

Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law").

Section 2. The following additional matters are hereby determined and declared:

- (a) The Notes shall be issued in anticipation of the collection of real estate taxes levied or to be levied for school purposes for the fiscal year commencing July 1, 2023 and ending June 30, 2024, and the proceeds of the Notes shall be used only for the purposes for which said taxes are levied.
- (b) The Notes shall mature within the period of one year from the date of their issuance.
- (c) The Notes are not issued in renewal of other notes.
- (d) The total amount of such taxes remains uncollected at the date of adoption of this resolution.

Section 3. The Notes hereby authorized shall contain the recital of validity prescribed by Section 52.00 of the Law and shall be general obligations of the District, and the faith and credit of the District are hereby pledged to the punctual payment of the principal of and interest on the Notes and unless the Notes are otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget of the District and a tax sufficient to provide for the payment thereof shall be levied and collected.

Section 4. Subject to the provisions of this resolution and the Law, and pursuant to Sections 50.00, 56.00, 60.00 and 61.00 of the Law, the power to sell and issue the Notes authorized pursuant hereto, or any renewals thereof, and to determine the terms, form and contents, including the manner of execution, of such Notes, and to execute tax certifications relative thereto, is hereby delegated to the President of the Board of Education, the chief fiscal officer of the District.

Section 5. The Notes shall be executed in the name of the District by the manual signature of the President of the Board of Education, the Vice President of the Board of Education, the District Treasurer, the District Clerk, or such other officer of the District as shall be designated by the chief fiscal officer of the District, and shall have the corporate seal of the District impressed or imprinted thereon which corporate seal may be attested by the manual signature of the District Clerk.

Section 6. This resolution shall take effect immediately.

13. Approval of Addendum to MAX Agreement (Enclosure)

WHEREAS, the Manhasset Union Free School District previously entered into an Agreement with the Manhasset Afterschool Xperience (MAX), dated July 1, 2022, for an after school child care program for the children of Manhasset residents for the 2022-2023 school year ("Agreement"), with an option to renew for the 2023-24 school year; and WHEREAS, the Board of Education has determined that it is in the best interests of the District and the school community to modify the rent for the 2022-23 school year and to renew services for the 2023-24 school year at a reduced rent, each in accordance with the District's applicable facilities use rates, due to the ongoing impact of the COVID-19 enrollment program; now. in the therefore. **RESOLVED**, that the Board of Education hereby approves the Addendum modifying the rent for the 2022-23 school year and extending the term of the Agreement to the 2023-24 school year at the applicable facilities use rates, and hereby authorizes the Board President to execute said Addendum on behalf of the Board.
